MUNICIPAL ORDINANCE NO. 110-2012

BE IT ORDAINED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled, that:

Section I – Title: This shall be known as “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 72-2006 FIXING THE NEW TARIFF RATES OF SIKAD-SIKAD IN POBLACION, MUNICIPALITY OF MAHAYAG, ZAMBOANGA DEL SUR.”

Section II – There is hereby imposed a new prescribed tariff rates of sikad-sikad offering public services and operating within the Poblacion, which shall be as follows:

Section III - A minimum fare of PhP5.00 is to be collected to a passenger and PhP3.00 to a child while students are charged PhP4.00 going to the route in the Poblacion which is not covered under Section II, hereof.

Section IV - Any fees and charges collected by any "*sikad-sikad*" driver in excess of the herein prescribed rates under Section II, hereof, is illegal and shall be a ground for the revocation of the permit to operate.

Section V - Any tariff rate of "*sikad-sikad*" found inconsistent under Section II, hereof, is hereby deemed modified, repealed or amended.

Section VI - This municipal ordinance shall take effect after public hearing and approval by the Municipal Mayor.
