**RESOLUTION**

**IMPOSING A PARKING FEE TO BIG COMPANIES OF PUBLIC UTILITY BUS  
PLYING THE ROUTES PASSING THE MUNICIPALITY OF MAHAYAG,  
ZAMBOANGA DEL SUR.**

WHEREAS, the Body has considered that, with the construction of road connecting the provinces of Zamboanga del Norte and Zamboanga del Sur via the Municipality of Sergio Osmeña there is undoubtedly a positive development of business industry especially transportation business which will be having routes along this road and in some other municipalities having an opportunity for this municipality to generate additional income in terms of revenues and other fees;

WHEREAS, thru a representative from LILIAN EXPRESS management, it was officially informed that they are opening now routes from Pagadian-Dumungag and vice-versa and Ozamiz-Dumungag and vice-versa which all these routes have to pass this municipality through its newly opened station;

WHEREAS, because of limited number of buses that will be fielded by the LILIAN EXPRESS there is a need to accommodate its management and other bus company in the near future regarding the monthly fees that will be payable to the municipality in order to encourage them to establish business in this area which later on could be a potential source of additional income;

**WHEREFORE:**

Be it resolved by the Sangguniang Bayan of Mahayag, Zamboanga del sur, to impose as it hereby imposes a parking fee to LILIAN EXPRESS and other transportation companies who are having routes of their buses passing this municipality.

Let this resolution be implemented under the following:

**MUNICIPAL ORDINANCE NO. 09**  
Series of 1991

**FIXING A PARKING FEE TO BIG TRANSPORTATION COMPANIES OF PUBLIC  
UTILITY BUS AT THE RATE, AS HEREIN PROVIDED:**

Be it ordained by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled that:

**SECTION I** - There is hereby fixed and imposed a parking fee to big transportation companies of public utility bus at the rate of **THREE HUNDRED FIFTY PESOS (P350.00)** per month, payable to the office of the Municipal Treasurer or through its authorized representative with corresponding Official Receipt therefore issued subject however for increases when a great number of buses will be fielded in the near future especially upon completion of road from Dipolog City connecting this province via the municipality of Sergio Osmeña.

**SECTION II** - That this ordinance shall only cover and apply to big transportation companies of public utility bus without tending to repeal existing ordinance concerning parking fee of individual buses and jeepney.

**SECTION III** - That this Municipal Ordinance shall become effective and enforceable after approval by the Municipal Mayor and review and approval by the Sangguniang Panlalawigan of this province or in the absence thereof upon the lapse of the reglamentary period as provided in the local government code.

ADOPTED this 16<sup>th</sup> day of August, 1991, thru acclamation.
