MUNICIPAL ORDINANCE NO. 101-2011

Be it enacted by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled, that:

Section 1 - Title: This shall be known as "AN ORDINANCE FIXING THE MONTHLY RENTAL AT PHP15.00 PER SQUARE METER OF THE MARKET BLOCKS IN POBLACION, OWNED BY THE LOCAL GOVERNMENT OF MAHAYAG, ZAMBOANGA DEL SUR."

Section 2 - Coverage: This ordinance shall cover all actual occupants in the commercial market blocks owned by the Local Government including the future occupants conferred on or vested with right by the legitimate occupants.

Section 3 - Privilege: A written contract shall be entered into by and between the municipal government and the present occupants of the market blocks under the nomenclature of LESSOR and LESSEE. Said contract, however, confers no absolute right to the lessee over the site.

Section 4 - Applicability: Any resolutions, ordinances or law consistent with this ordinance shall be valid and form part and supplementary to this ordinance.

Section 5 - Separability: Any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 6- Repealing Clause: All existing ordinances inconsistent herewith are hereby repealed or modified accordingly.

Section 7- Effectivity: This ordinance shall take effect upon approval by the Municipal Mayor and after review by the Sangguniang Panlalawigan of Zamboanga del Sur, or, in the absence thereof, upon the lapse of the reglementary period as provided in the New Local Government Code.
