MUNICIPAL ORDINANCE NO. 108-2012

Be it enacted by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled, that:

Section 1 - Tide: This shall be known as "AN ORDINANCE CREATING THE MUNICIPAL ECONOMIC ENTERPRISE AND DEVELOPMENT OFFICE (MEEDO), MUNICIPALITY OF MAHAYAG, ZAMBOANGA DEL SUR AND PROVIDING FUNDS THEREFOR,."

Section 2 - The Municipal Economic Enterprise and Development Office (MEEDO) shall function pursuant to the provision of Section 8, in the code of Economic Enterprise of the Municipality of Mahayag which office shall be headed by the Economic Enterprise Manager.

Section 3 - The Municipal Economic Enterprise and Development Office shall compose the following:

- a. Mahayag Local Water System;
- b. Municipal Market;
- c. Municipal Slaughterhouse;
- d. Municipal Transportation;
- e. Municipal Cemetery;
- f. Mahayag Municipal Hospital; and
- g. Josefina H. Cerilles State College-Mahayag Campus;

Section 4 - The Municipal Mayor through the Municipal Economic Enterprise and Development Office may recommend to the Sangguniang Bayan, this municipality, for its review and concurrence of such duties and functions pursuant to the Code of Economic Enterprise of the Municipality of Mahayag, Zamboanga del Sur.

Section 5 - Separability Clause: Any section or provision of this ordinance which may be declared unlawful or unconstitutional shall not affect the other sections and provisions hereof.

Section 6 - Repealing Clause: All ordinances, resolutions or laws of local effect inconsistent herewith are hereby modified, suspended or repealed accordingly.

Section 7 - Effectivity: This ordinance shall have a retroactive effect starting January 2011 and upon approval by the Municipal Mayor.
