MUNICIPAL ORDINANCE NO. 109-2012

Be it enacted by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled, that:

Section 1 - Title: This shall be known as "AN ORDINANCE MANDATING PERMANENT CLOSURE OF ALL QUARRY CONCESSIONS DOWNSTREAM FROM THE SALUG DAKU RIVER BRIDGE OF THE MUNICIPALITY OF MAHAYAG, ZAMBOANGA DEL SUR."

Section 2 - There is hereby imposed permanent closure of all quarry concessions downstream from the Salug River Bridge which had been destroyed last February 10, 2012 due to heavy floods and rampant quarrying resulting to the scouring of the riverbed for which this mandate shall continue in the future when a new bridge is constructed as replacement of the destroyed one.

Section 3 - Any person, concessionaires, government owned or controlled corporations or their representatives violating Section 1, hereof, shall pay a fine of Ten Thousand (PhP10,000.00) Pesos plus an imprisonment of not exceeding thirty (30) days as proper court may direct.

Section 4 - Copy of findings/assessment and recommendations by the Department of Public Works and Highways shall be made an integral part of this ordinance for perusal and reference of all concerned.

Section 4 - Repealing Clause: Any existing ordinance contrary or inconsistent with this ordinance is hereby repealed and amended.

Section 3 - This municipal ordinance shall be in full force and effect after approval by the Municipal Mayor and legal review by the Sangguniang Bayan of Zamboanga del Sur upon the lapse of reglementary period as provided for in the New Local Government Code.

ADOPTED this 13th day of April 2012, by acclamation.

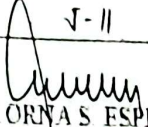

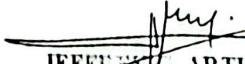
