MUNICIPAL ORDINANCE NO. 130-2014

BE IT ORDAINED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur during its session duly assembled, that:

Section I – Title: This ordinance shall be known as “AN ORDINANCE FIXING RENTAL RATES FOR CHAIRS AND TABLES OWNED BY THE LOCAL GOVERNMENT UNIT OF MAHAYAG, ZAMBOANGA DEL SUR.”

Section II – There is hereby fixed the amount of PhP5.00 per chair and PhP10.00 per table charged against any interested party desiring to rent the aforementioned furniture owned by this local government for which transport of the same from this municipality to the venue where such furniture are to be used and back to Mahayag shall be shouldered by the party and/or entity renting the said chairs and tables.

Section III – Rental of said furniture are allowed exclusively for interested parties in the barangays within the jurisdiction of the Municipality of Mahayag provided that the gathering or occasion for which the chairs and tables are used is duly permitted by the Municipal Mayor and/or his/her designated representative whenever applicable and for which such fees as aforementioned shall be issued the corresponding Official Receipt from the Office of the Municipal Treasurer.

Section IV – This municipal ordinance shall take effect immediately upon approval by the Municipal Mayor.
