RESOLUTION NO. 69

WHEREAS, Mr. James Cuizon, President of the Market Vendors Association, made a representation to this Body concerning the ununiformed charge of market stalls in the new super market building and the old market buildings;

WHEREAS, under Resolution No. 52, series of 1985 and Municipal Ordinance No. 85-03, the charge of market stall constructed in the super market per square meter daily is P.50 while those occupant in the market stalls in the old market buildings is P.25 only with 100% difference to the advantage of the other and disadvantage of another,

WHEREAS, the Body wishes to correct these ununiformed rates in all stall occupants in the three market buildings so that everybody could be given equal opportunity in the pursuit their business;

NOW, THEREFORE, on motion of Kagawad Leonardo P. Padilla, Sr. and duly seconded by Kagawad Bonifacio E. Nobleza, it was

RESOLVED, to amend, as it here by amends the Municipal Ordinance No. 85-03, particularly No. I, under Section I thereof, fixing uniformed rates of rentals for market stalls inside the public market buildings.

Let this Re solution be implemented under the following:

Res. No. 69, Mun. Ord. No. 88-02 Series of 1988 Page 02 -

MUNICIPAL ORDINANCE NO. 88-02

AN ORDINANCE FIXING UNIFORMED RATES OF RENTALS FOR MARKET STALL INSIDE THE OLD AND NEW SUPER MARKET BUILDINGS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Be it ordained and approved by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled that:

Section I – There shall be imposed uniformed rates of rentals for market stalls inside the old and new public market buildings at the rate of P.35 per square meter to be paid daily by a cash tickets to be issued by authorized market collections.

Section II – PENALTY. That any occupant of market stalls constructed inside any of the [public market buildings who deliberately and willfully fails to pay the required amount of rentals of the stall he is occupying for three consecutive days shall automatically establish a sufficient ground for termination of his contract and if he continues to refuse payment of the same for two consecutive weeks despite repeated warnings by concerned collectors, said occupant shall be deemed in default, thereafter the municipal government may order the demolition of his stall without cost but at the expense of said occupant in default.

Section III - REPEALING CLAUSE. That any existing Municipal Ordinance including No. I, Section I of Municipal Ordinance No. 85-03 which are contrary or inconsistent to this Municipal Ordinance is hereby deemed amended, repealed or modified.

SECTION IV – EFFECTIVITY. That this Municipal ordinance shall take effect upon the lapse of the reglamentary period or 15 days after its approval during the final reading and after copies of said Municipal Ordinance shall have been posted in any conspicuous places especially within the premises of the public market buildings whichever is later.
