MUNICIPAL ORDINANCE NO. 96-2011

BE IT ORDAINED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, during its session duly assembled, that:

Section I - Title: This shall be known as "AN ORDINANCE DECLARING ALL STALLS, ROOMS, SPACES AND BOOTHS WITHIN THE NEWLY CONSTRUCTED PUBLIC MARKET VACANT;"

Section II - Coverage: This ordinance shall cover the public market area operated and managed by the Local Government Unit of Mahayag, Zamboanga del Sur;

Section III - Policy Statement: Pursuant to the powers and authority granted to local government units by virtue of R. A. 7160 otherwise known as the New Local Government Code of 1991, the Municipal Government shall endeavor to be self-reliant and shall establish viable economic enterprises in order to augment its resources and generate employment;

Section IV - Manner and System in the Awarding of Stalls/Rooms/Spaces/Booths: The manner and system in the awarding of vacant stalls/rooms/spaces/booths shall be subject to the conditions under Article VI of the Municipal Economic Enterprise Code;

Section V - Applicability Clause: Any resolution, regulation, ordinance or law consistent with this ordinance shall be valid and form part and supplementary to this ordinance;

Section VI - Separability Clause: Any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect;

Section VII - Repealing Clause: All existing ordinances inconsistent herewith are hereby repealed or modified accordingly;

Section VIII - Effectivity Clause: This ordinance shall take effect fifteen (15) days upon approval by the Municipal Mayor, legislative review by the Sangguniang Panlalawigan of Zamboanga del Sur and after publication in one (1) newspaper of general circulation in the Province of Zamboanga del Sur.
