### RESOLUTION

AMENDING RESOLUTION NO. 11-180-2023 BY ADDITION, AND MODIFY ACCESS RIGHT TO LBP's INSTITUTIONAL INTERNET BANKING FACILITY known as "WeAccess", thereby AUTHORIZING JENEVIEVE L. TALIC, ADMINISTRATIVE ASSISTANT I, TO ENROLL IN THE SAID BANKING FACILITY AT THE LANDBANK OF THE PHILIPPINES – MOLAVE BRANCH, MOLAVE, ZAMBOANGA DEL SUR.

**WHEREAS,** on March 15, 2023, the Sangguniang Bayan of Mahayag has approved a Resolution designating/authorizing Ivy E. Colcol to act as Maker and Trilbe Loreign E. Abellana, CPA to act as Authorizer for the LGU's access to LBP's WeAccess banking facility;

**WHEREAS,** there is a need to authorize additional personnel to access this facility to ensure continuity and efficiency in banking transactions;

**WHEREAS**, the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of the same Code [Section 447(a), LGC of 1991];
