RESOLUTION

CONFIRMING AND RATIFYING THE AUTHORITY OF THE MUNICIPAL MAYOR, HON. MANUEL T. SALADAGA, TO ENTER INTO CONTRACT OF SERVICES WITH JHENIE D. RANILE, ALEX A. NINANG, MICHELLE ANGELICA A. BARABAD and NILYN T. GUMANDAM TO AUGMENT THE OPERATING WORK FORCE OF THE BARANGAY AFFAIRS, CSC and COA OFFICES, EFFECTIVE JULY 1 TO SEPTEMBER 30, 2024.

WHEREAS, the Barangay Affairs, CSC and COA Offices need the services of additional personnel who will assist in their functions and works so as to augment the operating work force of the said Offices;

WHEREAS, Section 444 (a)(1)(v)&(vi) of the Local Government Code of 1991 states that: the Municipal Mayor, as the Chief Executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by the same Code and other laws xxx, and in this connection shall: appoint all officials and employees whose salaries and wages are wholly or mainly paid out of municipal funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint xxx and upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991 and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of the same Code;

WHEREFORE, BE IT: RESOLVED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, to confirm and ratify, as it hereby confirm and ratify the authority of the Municipal Mayor, Hon. Manuel T. Saladaga, to enter into Contract of Services with JHENIE D. RANILE, ALEX A. NINANG, MICHELLE ANGELICA A. BARABAD and NILYN T. GUMANDAM to augment the operating work force of the Barangay Affairs, CSC and COA Offices, effective OCTOBER 1 to DECEMBER 31, 2024.

ADOPTED this 9th day of October 2024, on motion of Honorable Elmer C. Perez, and duly seconded by Honorable Marben M. Baker.


