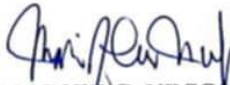
WHEREFORE, upon motion of Honorable Prisco J. Cleopas III and duly seconded by Honorable Elmer C. Perez, **BE IT:**

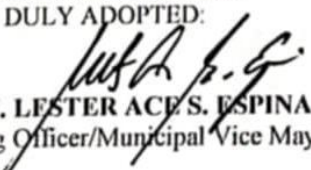
RESOLVED FINALLY, that this Resolution be forwarded to the Barangay Council of Kabuhi, for their information and basis of appropriate action.

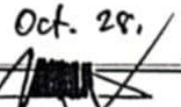
