RESOLUTION

AUTHORIZING THE MUNICIPAL MAYOR, HON. MANUEL T. SALADAGA, FOR AND IN BEHALF OF THE MAHAYAG MUNICIPAL HOSPITAL, THIS LGU, TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH BLANCIA HOSPITAL relative to THE PROVISION OF REFERRAL X-RAY SERVICES FOR PATIENTS REQUIRING RADIOLOGICAL EXAMINATIONS.

WHEREAS, a Resolution was requested for the authority of the Municipal Mayor to sign the Memorandum of Agreement (MOA) by and between the MAHAYAG MUNICIPAL HOSPITAL, this LGU, and BLANCIA HOSPITAL relative to the provision of referral X-Ray Services for patients requiring radiological examinations;


WHEREAS, in the pro-forma MOA, the obligations of each party, and other important provisions, are expressly stipulated which would serve as their guide for the supervision, management, coordination and implementation of the said MOA;

WHEREAS, for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code, the Municipal Mayor shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance, upon authorization by the Sangguniang Bayan [Section 444(b)(1)(vi) LGC of 1991];


Wherefore: BE IT RESOLVED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, to authorize, as it hereby authorizes the Municipal Mayor, HON. MANUEL T. SALADAGA, for and in behalf of the MAHAYAG MUNICIPAL HOSPITAL, this LGU, to sign the MEMORANDUM OF AGREEMENT (MOA) with BLANCIA HOSPITAL relative to the provision of referral X-Ray Services for patients requiring radiological examinations.


