RESOLUTION

ADOPTING REPUBLIC ACT NO. 10754 KNOWN AS AN ACT EXPANDING THE BENEFITS AND PRIVILEGES OF PERSONS WITH DISABILITY, AND ITS IMPLEMENTING RULES AND REGULATIONS.

Sponsor: Honorable Felipe A. Capadngan

WHEREAS, Republic Act No. 10754, otherwise known as "An Act Expanding the benefits and Privileges of Persons With Disability," was enacted to promote the rights and welfare of persons with disabilities (PWDs) in the Philippines;

WHEREAS, this law aims to enhance the well-being of PWDs by providing them with various benefits and privileges, including but not limited to discounts on purchases, access to government services, and other forms of assistance;

WHEREAS, the implementation of the provisions of this Act and its accompanying Implementing Rules and Regulations (IRR) is essential to ensure that the intended benefits reach the PWD community effectively;

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

Wherefore: BE IT RESOLVED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, to adopt, as it hereby adopts Republic Act No. 10754 known as An Act Expanding the Benefits and Privileges of Persons With Disability, and its Implementing Rules and Regulations.

RESOLVED further, that the People With Disability Affairs Office (PDAO) shall take necessary steps to disseminate information regarding the benefits and privileges available to PWDs, ensuring that they are aware of their rights and how to access these services.
