RESOLUTION

AUTHORIZING THE MUNICIPAL MAYOR, HON. MANUEL T. SALADAGA, TO SIGN A CONTRACT OF SERVICE BY AND BETWEEN JAYSON IN TOWN AND LGU MAHAYAG FOR THE REGGAE NIGHT 2023 IN THE 63RD ARAW NG MAHAYAG ON MARCH 7, 2023.

WHEREAS, presented for consideration of the Body is a request for authority of the Municipal Mayor to sign a Contract of Service by and between JAYSON IN TOWN for the Reggae Night 2023 in the 63rd Araw ng Mahayag on March 7, 2023;

WHEREAS, in the pro-forma Memorandum of Agreement, the obligations of both parties, and the other terms and conditions are expressly stipulated which would serve as their guide for the supervision, management, coordination and implementation of the said Event;

WHEREAS, for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code, the Municipal Mayor shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance, upon authorization by the Sangguniang Bayan [Section 444(b)(1)(vi) LGC of 1991];

WHEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, to authorize, as it hereby authorize the Municipal Mayor, HON. MANUEL T. SALADAGA, to sign a CONTRACT OF SERVICE by and between JAYSON IN TOWN and LGU MAHAYAG for the REGGAE NIGHT 2023 in the 63RD Araw Ng Mahayag on March 7, 2023.
