RESOLUTION

REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) – REGIONAL OFFICE IX TO CAUSE THE INSTALLATION OF ASPHALT OVERLAY ON BOTH SIDES OF THE NATIONAL HIGHWAY IN POBLACION, MAHAYAG, ZAMBOANGA DEL SUR, PARTICULARLY FROM BLISS UP TO THE MAHAYAG-JOSEFINA/DUMINGAG JUNCTION ROAD.

WHEREAS, this Body has observed that the uneven lanes in the national highway of Poblacion, Mahayag, particularly from Bliss up to the Mahayag-Josefina/Dumingag junction road, have caused and shall cause vehicular accidents, especially with single motorcycles that may easily slide or trip therein, damaging both lives and the vehicles;

WHEREAS, the DPWH is mandated to undertake the planning of infrastructure, such as national roads and bridges, flood control, water resources projects and other public works; and the design, construction, and maintenance of national roads and bridges, and major flood control systems;

WHEREAS, one of the policies of this Body is to ensure road safety among residents, tourists, motorists and passersby; thus, this request for installation of asphalt overlay on both sides of the national highway in Poblacion, Mahayag, Zamboanga del Sur, particularly from Bliss up to the Mahayag-Josefina/Dumingag junction road so as to prevent the occurrences of vehicular accidents;

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of the municipality and its inhabitants pursuant to Section of the Local Government Code of 1991 and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of the same Code [Section 447(a)(1), LGC of 1991];

WHEREFORE, BE IT:

RESOLVED by the Sangguniang Bayan of Mahayag, Zamboanga del Sur, to request, as it hereby request the DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) – REGIONAL OFFICE IX to cause the installation of asphalt overlay on both sides of the national highway in Poblacion, Mahayag, Zamboanga del Sur, particularly from Bliss up to the Mahayag-Josefina/Dumingag junction road.

Let a copy of this Resolution be forwarded to the Office of the Regional Director of the Department of Public Works and National Highways (DPWH) – Regional Office IX, for appropriate and favorable action.
