## RESOLUTION

ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) RESOLUTION NO. 2, SERIES OF 2022 DATED JULY 27, 2022, ENTITLED "A RESOLUTION RECOMMENDING THE REALIGNMENT OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT INVESTMENT FUND FOR CY 2022 IN THE AMOUNT OF 3,250,000.00 TO AUGMENT THE FUNDS NEEDED FOR RECOVERY AND REHABILITATION AND TO MITIGATE RISK CAUSED BY TORRENTIAL RAINS THAT RESULTED TO FLOODING IN LOW LYING AREAS."

WHEREAS, presented before this Body, under urgent measure, is MDRRMC Resolution No. 02, series 2022, dated July 17, 2022, entitled "A Resolution Recommending the Realignment of the Municipal Disaster Risk Reduction and Management Investment Fund for CY 2022 in the Amount of 3,250,000.00 to Augment the Funds Needed for Recovery and Rehabilitation and to Mitigate Risk Caused by Torrential Rains that Resulted to Flooding in Low Lying Areas", for adoption and appropriate action;

WHEREAS, considering the urgency of this matter, this Body has ruled the adoption of the aforesaid Resolution as the same is geared towards the general welfare of the constituents and for the recovery and rehabilitation and/or to mitigate risk caused by torrential rains that cause flooding along the major rivers and creeks of Mahayag which resulted in some unforeseen effects, such as soil erosion along the river banks of Tumapic, Bag-ong Balamban, Tulan and Malubo, partial damage of the approach of San Jose-DCM Bridge, Poblacion-Deluson spillway, and Lower Sto. Niño-Katipunan Bridge; and the accumulation of river aggregates along rivers and creeks and high levels of flood at Purok 4 Manguiles and Purok 3 Kaangayan (IP Housing);

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of the same Code [Section 447(a), LGC of 1991];

NOW, THEREFORE, on motion of Honorable Prisco J. Cleopas III and jointly seconded by Honorable Elmer C. Perez, Honorable Antonio P. Watin and Honorable Felipe A. Capadngan, BE IT:
